Proposition 19 - No Repeal This Year. Ever?

Many volunteers attempted to gather enough signatures to get an initiative on the ballot to repeal Prop 19. They failed.

This means that Prop 19 is here to stay, at least until another effort is launched in coming years.

So, what should you do?

Our first thought is that, in our view, it will be extraordinarily difficult to repeal Proposition 19. There are many reasons:

- 1. Proposition 19 is complicated and has many provisions, some of which are very favorable. Will a repeal seek to undo everything or only the property tax elements?
- 2. The Realtor's Association substantially funded the campaign to pass Proposition 19. We expect them to, directly or indirectly, oppose efforts to repeal the property tax implications of Proposition 19. Housing

inventory is near historic lows, increasing the pressure to keep Proposition 19.

- 3. Teacher and government unions understand that the property tax increases will substantially increase revenue at the local levels, which could result in increased compensation and benefits.
- 4. Renters and owners of modestly priced homes do not oppose Prop 19.

The original Proposition 13 Jarvis-Gann movement is somewhat revitalized in California, so it will be more than interesting.

Again, what should you do? Anything can happen, including your passing while Proposition 19 is in effect. An individual with a limited life expectancy and real property holdings should obviously act immediately to lock in current levels of property tax while able to do so. Individuals with very large real property holdings should also act now, particularly since the approach can be structured so that tax benefits are captured even if Proposition 19 is repealed.

If you are young, healthy, and have relatively modest real property holdings, it makes sense to watch, monitor developments, and stay in close touch with us since we will report any and all developments.

This had a rippling effect that generated the need to update virtually all of their documents since this child was named as a successor trustee and as the attorney in fact in the Durable Power of Attorney.

They also brought a daughter who is now to be named as the primary successor trustee. She had the opportunity to ask a dozen questions about what it means to be a successor trustee.

Ms. S just experienced a divorce and has all of her own assets in her own name. Her husband gave us permission to provide her with estate planning services (since we had confidential information about him). In the nofee hour, we gathered all information needed to prepare a new, updated estate plan that favors family members — and that rather specifically disinherits her ex-husband!
